Call to Order

President Paul Kruse called the Genoa-Kingston CUSD #424 Committee of the Whole meeting to order at 6:37 pm.

Task Force Survey Review

Mr. Burgess and the board continued the discussion on the NIU Survey completed for the district on Bullying and Harassment. Mr. Burgess stated administration will focus on moving forward in staff development and communication with families. Mr. Burgess also stated there will be another Task Talk presentation titled: Bullying is never Right, by Angelo Lekkas, on Wednesday, January 27, 2016 from 6:30 – 7 pm in the GK High School Media Center. Mr. Burgess commended Mr. Lekkas for his efforts and presentations to parents.

Edwards asked how the survey comments would be addressed. She also asked if a school messenger will be sent out as a reminder of the Task Talk.

Mr. Burgess stated it is important to continue the Task Talks as well as student education. He also stated a school messenger will be sent out about the presentation.

Mr. Burgess stated "How do we deal with bullies", was brought up a lot in the survey. He also stated many times bullying is happening outside of school.

Gustafson stated cyberbullying is a very different situation.

Fischer recommended blocking or deleting someone who is posting bullying comments or inappropriate things.

Brynteson stated education on dealing with cyber bullying would be important. She also recommended blocking and deleting a cyber-bully.

Mr. Burgess stated the district has internal blocking. He also stated by a parent providing the data plan they are perpetuating it. He further stated the district can only do so much.

Andrews stated a group shared with her the fear of reported bullying could lead to retaliation.

Lauderdale asked if it was necessary for students to have cell phones in school.

Brynteson stated there are a lot of positive educational tools and resources students have access to on their cell phones. She also stated the importance of teaching phone etiquette and moderation of the use of cell phones.

Kruse recommended education of social media etiquette.

Mr. Francis stated the last GES Character Counts lesson was about cyber bullying. He also stated continuing to model what students should do when bullied. He further recommended blocking a person from a cell phone and telling a teacher or principal. Mr. Francis stated we cannot address a situation we are not aware of. He also stated the survey is important, but it is also important to advise an administrator about a problem.

Brynteson stated many parents are friends with their students on social media. She also stated telling kids not to bully yet parents are doing this on social media. She further stated this does not set the proper examples. Brynteson stated the earlier students know how to manage electronics the better. She also recommended educating students in that once you put something on social media such as, a picture or words, the whole world will see it.

Vision 20/20

Mr. Burgess shared the agenda for the next Vision 2020 meeting scheduled for Thursday, January 21, 2016 at 6:30 pm in the high school library. He also stated reviewing the committee's work and upcoming G-K Tech Expo which combined with the Genoa Chamber Business Expo is scheduled for Saturday, March 5, 2016 from 10 am. – 3 pm.

Mr. Burgess stated Vision 2020 discussion will include Maker Space and Project Lead the Way updates, Chromebook use for 2016-2017, staff training needs and future presentation ideas.

Brynteson recommended middle school and high school students attend the SIT conference on February 20, 2016 at DeKalb High School.

Kruse recommended communication of model behavior between students and future employees would be beneficial. He also stated students should be aware that future employees may look at their social media accounts prior to employment.

Mr. Burgess stated there will be a Project Lead the Way (PLTW) Open House at Genoa-Kingston Middle School on Tuesday, January 26, 2016 from 12:00 pm. – 2:30 pm.
